- ❷ **TV SHOWS, EXHIBITIONS OR MULTIMEDIA PRESENTATIONS;** and
- ❸ **REALIZED ARCHITECTURAL WORK** completed in the same period.

Individuals, institutions, associations, professional organizations, as well as all interested persons who have accomplished the results in one of the three categories, from the territory of Serbia, as well as other countries have the right to participate in the Competition. The Competition has been announced in accordance with the **“Ranko Radović” Award RULES** and starts from Monday, 2<sup>nd</sup> September, 2013. Deadline for receiving works is 15<sup>th</sup> October 2013.

During March 2014, the Exhibition shall be held at the Faculty of Technical Sciences in Novi Sad.
